The State of Governance in Bangladesh 2010-11 Launching Ceremony held

The research team of the Institute of Governance Studies (IGS) produced the Institute's flagship report – "The State of Governance in Bangladesh: Policy,

Influence, Ownership" 2010-2011. The formal launching ceremony of the publication was held on 21 November 2012 at BRAC Centre Inn. The programme inaugurated with the welcome address by Dr. Rizwan Khair, Director, IGS. The event was chaired by Professor Ainun Nishat, Vice Chancellor, BRAC University. The presentation on the key findings of the report was made by M. Shahidul Islam, Research Fellow, IGS. The two panel discussants of the event were Dr. Akbar Ali Khan, Professor, BRAC Business School and former Adviser to the Caretaker Government and Dr. Hossain Zillur Rahman, Executive Chairman, Power and Participation Research Centre (PPRC) and former Adviser to the Caretaker Government. Distinguished academics, researchers and experts and practitioners participated in this programme.

International Conference on Governance and Public Service Transformation in South Asia held in Dhaka

Institute of Governance Studies (IGS) and Affiliated Network for Social Accountability - South Asian Region (ANSA-SAR) in collaboration with United Nations Development Programme Asia-Pacific Regional Centre and United Nations Millennium Campaign – Asia & Pacific Region, Public Affairs Centre (PAC) India, Monash University Australia and North South University, organised a two- day conference (08th -09th December) at the Pan Pacific Sonargaon Hotel for ensuring equitable and inclusive development in South Asia as well as influencing the ongoing international dialogue on United Nations Post 2015 Development Agenda. The Inaugural Ceremony was attended by Dr. Gowher Rizvi, International Affairs Adviser to the Prime Minister of Bangladesh as the Chief Guest, Stefan Priesner, Country Director, UNDP Bangladesh and Dr. Salman Zaidi, Lead Economist of The World Bank, Bangladesh as distinguished guests. Dr. Mahabub Hossain, Executive Director, BRAC, Chaired the occasion, Dr. Rizwan Khair, Director, IGS of BRAC University presented a detailed overview on the objectives of the conference. The welcome note was delivered by

Nuzhat Jabin, Programme Manager of ANSA-SAR to the delegates from over 10 countries (Bangladesh, India, Pakistan, Sri Lanka, Egypt, the Philippines, Switzerland, Australia, UK and The Netherlands).

The opening ceremony also saw the unveiling of ANSA-SAR compendia on Social Accountability Experience in India, Sri Lanka and Bangladesh in the form of 3 publications.

After two and a half days of discussions and deliberations at the International Conference on Governance and Public Service Transformation in South Asia, the delegates adopted the Dhaka Declaration. The Declaration 'noted' South Asia, being the home to the largest concentration of people living in poverty on earth, presents a depressing paradox in the global poverty landscape and the need for efforts to be adequately

resourced at multiple levels of the implementation chain; The Declaration noted the need for decentralisation and strengthening of local governance systems; and to provide robust accountable frameworks for effective regulation and guidance of public service agencies. It further recognised that access to public information is central for inclusive, informed and accountable civic engagement, and reiterated the importance of open government by expanding reach of ICT, mobile phones and social media.

The Declaration reiterated the lessons from the implementation of MDGs highlight the role and contributions of democratic governance as one of the critical determining factors to achieve and sustain development outcomes. It emphasised on the need for correcting the inherent dichotomy of poverty in the midst of growth, demanded among others, efficient public administration and transparent, participatory and accountable governance processes. It also encouraged the adaptation and application of a wide range of instruments and tools to promote citizen's voice and deliver specific development goals in South Asia. The Declaration reinforced the idea of establishing effective accountability mechanisms which facilitates a stronger Citizen-State relationship, where people have a voice in governance and decision making processes.

Recalling the new opportunities and tools available to media, civil society, academia and social entrepreneurs to measure government performance, the Declaration emphasised the need to support constructive engagement of citizen groups with governments and public service delivery agencies at the national and local levels. It was highlighted in the Declaration that these approaches need to be contextualised to meet emerging needs of regions and special population. The Declaration recommended specific attention to be given to issues related to gender inequality in socio-economic, education and employment and inadequate participation of marginalised communities in the achievement of development goals; and called for appropriate actions in this direction.

The Declaration re-affirmed the centrality of strengthening governance capacities at all levels to help foster innovations in governance processes and the urgency of the process of re-thinking the Millennium Development Goals, and to utilise the time between now and 2015 to recast the MDGs with renewed spirit and purpose.

Finally, the Declaration called for collective augmentation of research efforts to encourage co-creation, assimilation and dissemination of knowledge with regard to design and implementation of development initiatives and interventions of the MDGs. It further encouraged academia, civil society groups, national governments and multinational aid agencies to take into account the Dhaka Declaration on Governance in their future endeavours of enhancing governance capabilities in South Asia.
