
1.3 Organizational structure, Organogram, Branches and departments.

2.2 Administrative Department:

They have to maintain factories security, housekeeping, local issues and paperwork with relevant office. It was pleased to do that I was a part these types of tasks which they do/did for their organization along with I did some legal issue with admin officer of the company. He teaches me how to control and manage the duty roster of the security and others. Administrative department is to manage security or they have to fix up their duty roster or plan where they will duty or work in a day or night shift. 2.3 Cutting Department:

Production begins with the cutting department because every fabric or sheet needs to do cut first then make it finish goods or products that is why this is a first step to make final products of goods. In this organization they are used to make geo sheet tube bags or sand fill bags as well. From my side, I was involved this department how to do their daily tasks of job such as; cutting width, length with proper measurement as well how to lay the geo sheet for cutting the bag or tube sizes. I have seen and leant all those things form the production supervisor practically when I was there. It was really happy journey with them to do production report, measure bags length and width as well. Supervisor was so cooperative to do so for me to learn how they work. I have made daily production report when I was there

with them to make. In order to do my internship I was glad to see how they work and how they effort to do their particular responsibilities. My responsibility was to learn from them how they work for this department. They have a particular target for a period of time like a day or shift or hours. I have learnt from them how fix up hourly/day target and how to achieve it end of the day/hour or shift for supervisor or shift in-charge or production people. I have learnt how to achieve hourly target by monitoring machine to machine target achieved or not. Sometimes it is very hard to achieve to meet the daily target or achievement. Work in this department now I am able to do it very smoothly in lieu of production people or supervisor.

2.4 Sewing Department:

Sewing department is man machine department to make a cut panel to a finished good or final products by sewing. I was involved to identify how they use man machine ratio to use less manpower for getting maximum output. How they set up target. I have learnt from the departmental production Manager and Supervisor to make daily MIS report, weekly production report and monthly production report. I have seen it and done it form my side very carefully to get helped by the production supervisor as well. I have learnt some technical activities form mechanic supervisor how to fix up the machine if there is trouble. I have leant how to set up thread on the machine to sew the product form the mechanic supervisor on the mentioned department. It was an amazing learning for me that every stitch is valuable. I have accomplished many things what I did for the certain period of time for being there my internship duration where I got chance to do internship.

2.5 Finishing Department:

This is the last department those who are involved to finish products or goods for final

delivery to final customer. Every department plays a vital role individually among them finishing department is one of them. Finishing department is to ensure quality products or goods to get satisfactory report from their valued customers. I have accomplished to see how to do inspection of a products, how they check four point inspection as well. How to make Defect per hundred units (DHU). As an intern I have leant from them it so quickly to observe their particular job in a day. After learning I have applied all things to come up with finishing in-charge. He is a very gentle man that I have seen ever. I have checked and done with him to inspection practically. It was great journey with them to have finished my internship duration.

2.6 Others Department:

In this regards I want to tell that I have accomplished my internship more departments to boost up career and I have great opportunities form my industrial supervisor who has given a chance to work so many department as well. I have also worked minimum eight to ten departments in lieu of five departments. Such as, Accounts, Store and others production departments. It was my great opportunities to work my internship done. In general I have leant how make journal to input dynamic and how make to top sheet then get approval from factory head. All I have leant from the Accounts Executive as well.

Cutting department: Cutting is wide area to supply cut panel to the sewing department to make a complete body or bag but there is a limitation to cut in a day. They are used to cutting their geo sheet by manually which is very dangerous for the cutting people. It may create hazard any time for the cutting people.

Sewing department: There is an also limitation for the sewing machine because it has limited machine to produce the geo bags and tupe bags which is not good practice for their reputation and meet the daily production and customer needs.

Wastage of the products: Wastage of the product is very high because of lacking of skill workers and supervisor in this sector to make the final products from the raw materials that is why they do not have proper production knowledge how to make it properly to measure.

The company's operating system is going to be very well and organized. After finishing my 03 months internship I want to give some vital points to improve the industry as per good aspects and weakness of the company accordingly.

At first the company should keep their good aspects alive to sustain their business to be a leading Geo textile company in Bangladesh. They must follow their competitor to retain their

items in the market. The company should develop their people to achieve goals and objective accordingly.

To reduce process wastage and time wastages to make the products again and again. The company enlarge their cutting limitation to use machine in lieu of manual cutting to increase their cutting panel to supply more to the sewing department to increase production for the end the month as well as sales.

Limitation of sewing machine should increase gradually in the sewing floor to meet the current market by making vast production to get back more revenue. The company should bear in mind to increase sewing machine like as others machine or department. To become a top leading Geo textile company should be more careful about their business and customer.

3.3 Learning for self-improvement:

Duration of my internship I have learnt a lots of thing to improve myself to become a successful in my career. It has given me a lot theoretical and practical in my internship and course duration. I have spent approximately 70 days for my internship. In this duration I have achieved some remarkable things which cannot get easily of the job market.
