2.3 Organization Hierarchy




Figure: Operational Hierarchy

5.1.1 Foreign Exchange Inflow




Chart 01: Foreign Exchange Inflow

5.1.2 IT Infrastructure




Chart 02: Infrastructure of IT

5.1.3 Economic Growth and Employment Generation




Chart 03: Economic Growth and Job Creation

Business Process Outsourcing companies use technology advantages for development. DataPath Limited has increased its boost productivity and service quality with advancement in technology.


Threats
