SHARIQUE National Seminar on Social Accountability Mechanisms in the Union Parishad



Distinguished Guests at the National Seminar on Social Accountability Mechanisms

Provision of Ward Shobha, twice in a year, promulgated in the Local Governance Act (UP) 2009, to ensure social accountability of Union Parishad through participation of men-women and poor in its activities and improving the quality of its service, the programme couldn't be successful all across the country, experts said in a National Seminar titled Social Accountability Mechanisms in the Union Parishads on May 30th, 2015, jointly organised by BRAC Institute of Governance and Development (BIGD), BRAC University and HELVETAS Swiss Intercooperation, Bangladesh.

Presided over by Barrister Manzoor Hasan, Executive Director, South Asian Institute of Advanced Legal and Human Rights Studies (SAILS) and Institutional Advisor, BIGD Mr. Ashok Madhab Roy, Additional Secretary, Local Government Division, attended the event as the Chief Guest. Dr. Tofail Ahmed, Visiting Fellow, BIGD presented the keynote speech based on a study.

Mr. Nazrul Islam of UNDP and Mr. Arif H. Khan of Manusher Jonno Foundation (MJF) have also made two separate presentations on Union Parishad Governance Project (UPGP) and CARTA respectively.

Dr. Salauddin M. Aminuzzaman, Professor, University of Dhaka and Dr. Mirza M. Hassan, Adjunct Fellow, BIGD discussed on the presentations.

In his keynote presentation, Dr. Tofail Ahmed, the reputed Local Government Expert highlighted the research findings which shows, currently the Ward Shobhas lack of agendas, proceedings of meetings and proper conforming of the regulations; reflection of demands of members in the Shobhas and serious violations of rules in some places i.e inactivity of the Standing Committees, poor tax assessment, updated RTI etc. He also added, no open budgets are being made following the instructions and the budget lacks proper planning. Among others, the findings include scarcity of skilled workforces of the UPs, inadequate

allowances considering many informal public interactions of UP representatives and daily dispute reconciliations alongside all the responsibilities.

Earlier, Lilia Tverdun, Director, Local Governance Programme Sharique made the introductory remarks and welcomed the distinguished guests and participants which includes, Experts, Academics, Activists, UP representatives from Pabna, Sunamganj, Rajshahi, Chapainawabganj, Khulna, and representatives from public and private organisations, different INGOs, NGOs, Donor Agencies and Media.

Mr. Ashok Madhab Roy stressed on the interaction and relation improvement between the people and the representatives; increasing public awareness about the duties and responsibilities of UPs, enhancing the revenue of the UPs to strengthen local governments income and make the Ward Shobhas more operative. He said people skip Ward shobhas as their demands are not attended plentifully, and the housewives avoid the Shobhas as they consider the Shobhas should be attended by their husbands. He also suggested the UP Chairmen to raise their objections in the Upazila Parishads meetings as active members. In reply to the question on excessive number of committees at UPs, he said most of the committees are formed considering social safety net issues and it is not necessary to organise meetings of all the committees every month.

Professor Salahuddin M Aminuzzaman urged to plan and make decisions through analysing the economic and political condition of the rural areas. He said UPs are overweighed by number of committees. He suggested keeping 5-6 committees instead of 28. He added, it's impossible for one secretary to look after all the duties and responsibilities of UP.

Dr. Mirza Hasan said social accountability mechanism will work as a defensive tool in today's severe crisis of political democracy. He urged to free local government from partyarchy as UP representatives are forced to maintain dual accountability as apart from people, they also have to abide by particular political party. He asked for a justifying socio-economic system following these research findings.

Later, an open discussion on Policy Briefs, based on study was moderated by Maheen Sultan, Advocacy Specialist, BIGD where peoples representatives asked to cancel the regulation which instructs to follow the suggestions of the Member of Parliaments (MPs), as the suggestions arrive in the form of orders, according to the representatives. They mentioned it as a significant constraint similar to political interference and bureaucratic impediments.

The event concluded by the closing remarks of Ms. Melina Papageorgiou Trippolini, Programme Manager, Embassy of Switzerland in Bangladesh.

The consultation meeting was inaugurated by Dr. Minhaj Mahmud, Head of Research, BIGD. Dr. Rizwan Khair, Director, BPATC also spoke at the inauguration ceremony.

Followed by the inauguration, two individual plenary sessions on Project Cycle Management and e-governance courses were moderated by Mr. Md. Mosta Gausul Hoque, PMP, Director (Planning and Development), Bangladesh Parliament Secretariat and Mr. Shah Mohammad Sanaul Hoque, Capacity Development Specialist, Access to Information (A2I) programme, Prime Minister's Office respectively, which included presentations on each courses by BIGD Researchers Mr. Sirajul Islam and Md. Harun-Or-Rashid; group discussions and final presentation by two individual group representatives with feedback. BIGD Honorary Fellow Dr. Tofail Ahmed delivered the concluding remarks.

The objective of the consultation was to further develop the course in order to enhance the capacity of the prospective course participants. E-Governance is a two weeks short course aiming to enable e-governance Managers of both the public and private sectors in Bangladesh to develop required competencies in ICT and e-Governance management. A curriculum development team both from the BPATC and the BIGD developed this course in competence based teaching and learning framework through a series of workshops held in The Netherlands and Bangladesh. And the Project Cycle Management (PCM) is a two weeks long short course aiming to enable project management officials to manage projects through effective and efficient use of resources.

BIGD Researchers Syeda Salina Aziz and Md. Harun Or Rashid shared the key research findings of the research. The research looked at the contexts, process and challenges faced by women migrants in Bangladesh, funded by Gender, Justice and Diversity Department of BRAC. Dr. Sultan Hafeez Rahman, Executive Director of BIGD chaired the event.

The workshop started with an introductory speech given by Sheepa Hafiza, Director of Gender, Justice and Diversity Department of BRAC. Syeda Rozana Rashid, Associate Professor of the Department of International Relations, Dhaka University and Research Fellow of the Refugee and Migratory Movements Research Unit (RMMRU), discussed on the research report as Panel Discussants.

BIGD in National and International Programmes

BIGD Executive Director Chaired a session at 'High Level Meeting on South-South Asia and Triangular Cooperation in the Post-2015 Development Agenda'

Dr. Sultan Hafeez Rahman, the Executive Director of the BIGD, BRAC University, attended as one of the main speaker in a two-day 'High Level Meeting on South-South Asia and Triangular Cooperation in the Post-2015 Development Agenda' held on 17th-18th May, 2015 at Sonargaon Hotel, organised by the Economic Relations Division of the government, in partnership with the United Nations Office for South - South Cooperation and UNDP.

H.E. Sheikh Hasina, the Prime Minister of the People's Republic of Bangladesh, adorned the ceremony as the Chief Guest. Mr. Abul Maal Abdul Muhit, Minister of

Finance, People's Republic of Bangladesh and Mr. Abul Hasan Mahmood Ali, Minister for the Foreign Affairs of the People's Republic of Bangladesh chaired the Opening and Closing session of the event respectively.

Developing countries should stop running after low-hanging fruits but rather develop connectivity among them to promote sustainable development, analysts said at the meeting. South-South Cooperation is the mutual sharing and exchange of development solutions - knowledge, experiences and good practices, policies, technology and resources - between and among countries in the global South.

Triangular Cooperation involves partnerships between two or more developing countries along with a third partner, typically a traditional resource partner and/or multilateral organisation.

Dr. Sultan Hafeez Rahman said, 'South-South cooperation is possible, and it can be built through multimodal connectivity such as physical connectivity and ICT. If we can do that, it will ultimately spur economic growth in developing countries and lift billions of people out of poverty,' he added.

Dr. Rahman also said nothing would happen if there is no strong political commitment from governments. Countries also cannot bypass local communities, apart

from political sensitivity, when they construct any infrastructure. Dr. Rahman said there has been rapid change in the areas of ICT, communications and people-to-people connectivity in recent times.

He added, apart from financial support from the World Bank and the Asian Development Bank, huge funds are available following setting up of the Asian Infrastructure Investment Bank and the Silk Road plan, both led by China.

In another session, speakers called for enhancing South-South cooperation in science, technology and innovation between least development countries and emerging economies.

The theme of the high-level meeting was 'South-South and Triangular Cooperation in the Post-2015 Development Agenda: Financing for Development in the South and Technology Transfer,' the event brought together Government ministers, senior officials and practitioners both from the South and the North for discussions on how South-South and triangular cooperation could be better oriented towards the attainment of internationally agreed upon development

goals today and in the years ahead. Bangladesh hosted the High-level meeting at a time when the country holds the Presidency of the High-level Committee on South-South Cooperation, the highest body in the United Nations for the promotion of South-South Cooperation. The event aimed at sharing of knowledge, experiences and best practices in financing for development and technology transfer towards the achievement of the post-2015 development goals.

State Minister for Finance M A Mannan attended the workshop as Chief Guest while former Bangladesh Bank Governor Dr. Salehuddin Ahmed, and former Vice-Chancellor of Bangladesh Agriculture University Dr. M A Sattar Mandal were also present as the special guests.

Presided over by Managing Director of PKSF Abdul Karim, the function was also addressed, among others, by Additional Secretary, Ministry of Fisheries and Livestocks Mr. Anisur Rahman, Director General, Department of Fisheries; Dr. Syed Arif Azad and South Asia Country Director of Worldfish and BSFF Chairman, Syed Mahmudul Huq.

At the seminar, a memorandum of understanding was also signed between PKSF and BSFF for mutual cooperation and sharing of expertise.

The workshop was organised attuned to the outcomes and findings of a project titled 'Building trade capacity of small-scale shrimp and prawn farmers in Bangladesh: investing in the bottom of the pyramid'

Speakers at the policy workshop underscored the need for introducing contract farming arrangements for production of safe and quality shrimp and prawns for greater penetration of Bangladesh products to international market. They also put emphasis on innovation of appropriate technology for reducing the risks of diseases in shrimp and prawn aquaculture and evolving a National Code of Conduct for responsible aquaculture.

BIGD's Head of Research co-presented a paper on the ISA Workshop on Foreign Aid and Government Legitimacy

Dr. Minhaj Mahmud, the Head of Research of BIGD, BRAC University along with Mr. Simone Dietrich, Assistant Professor of Political Science, University of Missouri, Columbia and Mr. Matthew Winters, Assistant Professor of Political Science, University of Illinois, co-presented a paper titled 'Evaluating the Effects of USAID Branding on

Government Legitimacy: Survey Experimental Evidence from Bangladesh' at the International Studies Association (ISA) Workshop on Foreign Aid and Government Legitimacy held at Georgetown University in Washington D.C. on April 11th, 2015.

Apart from presenting paper, Dr. Mahmud also played his role as discussant at the Concluding Remarks, Reception and Poster Session.

Prof. Irfan Nooruddin and James Vreeland acted as local hosts. The workshop brought together academics, applied researchers and policy-makers to discuss frontier issues in the study of foreign aid and governance in aid-receiving countries. It also aimed to identify

future research directions, and to provide opportunities for exchange and collaboration among scholars and policymakers.

Dr. Sultan Hafeez Rahman, the Executive Director along with Ms. Simeen Mahmud, Fellow & Coordinator, Gender Studies Cluster and Ms. Lopita Huq, Research Fellow of BIGD, BRAC University participated at the conference titled 'Towards Sustained Eradication of Extreme Poverty in Bangladesh,' co-organised by the General Economic Division (GED) of Planning Commission of Bangladesh, Bangladesh Bank and Bangladesh Institute of Development Studies (BIDS), held at the NEC

Conference Room, Planning Commission Campus in Dhaka on April 8th-9th, 2015.

The Honorable Planning Minister of Bangladesh Mr. AHM Mustafa Kamal (Lotus Kamal) inaugurated the conference whilst M.A. Mannan MP, State Minister, Ministry of Finance & Ministry of Planning and Ms. Pauline Tamesis, Country Director of UNDP in Bangladesh spoke on the occasion.

The Honorable Planning Minister of Bangladesh Mr. A H M Mustafa Kamal (Lotus Kamal) inaugurated the conference whilst State Minister for Finance and Planning and UNDP Country Director in Bangladesh spoke on the occasion. The event was adorned by renowned economist from all over the world.

The current economic growth, lack of reflection of success stories on poverty reduction, assurance of public service delivery to the poor and increased budget allocation for real social programmes to eliminate extreme poverty were the main issues of this conference.

Dr. Sultan Hafeez Rahman chaired a session titled 'Inequality and Financial Inclusion.'

The economists attending the programme have suggested to focus on eradicating poverty in the upcoming 7th five-year development plan, enhancing public investment in the social safety-net programmes for vulnerable groups, and enhancing foreign direct investment.

They said the government will have to ensure that the social safety-net programmes reach to real vulnerable groups in the country by checking fraudulence in resources distribution.

They also opined that graduation to a middle-income country does not mean that the poverty is eradicated properly. Rather the extreme poor will have to get all the state facilities to boost their socio-economic condition.

Ms. Simeen Mahmud and Ms. Lopita Huq presented a paper on 'Women in poverty: capability and wellbeing' at the Conference which implicates different experience of poverty of men and women within and beyond the households level and also emphasised to understand

how 'social norms' impose constraints on women's choice and agency regardless of poverty, which later on described in the paper.

The conference was organised by the General Economics Division of the Planning Commission in collaboration with Bangladesh Bank and Bangladesh Institute of Development Studies (BIDS) with support from DFID and EEP/Shiree.

BIGD Researcher met Dr. Michael M. Cernea

BIGD and Manchester University's joint Research Initiative

BIGD is embarking upon a new research on health sector policy processes in partnership with Manchester University, UK titled 'Political Settlement and Health Sector Dynamics in Bangladesh.' The research will identify the key actors in the political settlement, and examine their roles and contributions in the processes through which policy decisions are reached, operationalised and implemented, and agendas are set. Given that financial and governance deficits will increasingly become a real constraint on health sector

performance and quality of care, a major aim of the research is to understand whether the prevailing 'elite consensus' will recognise and be responsive to these altered need. The proposed research is particularly relevant and important for this sector, given that Bangladesh is perhaps reaching the limits of success in health sector performance that such a weak governance structure will permit. The transcription, literature review, in depth interviews, data collections of the research project are ongoing.
