The Institute of Governance Studies (IGS) organised a roundtable discussion titled 'Health Sector Governance: Policy, Influence, Ownership' on July 27, 2013 at BRAC Centre Inn Auditorium, Dhaka. The roundtable was organised as a follow-up event of the research report titled 'The State of Governance in Bangladesh 2010-2011: Policy, Influence, Ownership'.
