


Figure 1: Organization Hierarchy





Figure 3: Buyer Wise Export data chart

Chapter 2

In garments manufacturing operation segments includes Merchandising, Product development, Cutting, Sewing, Finishing, Industrial Engineering etc.

<u>Merchandising and marketing department</u>: Marketing department is named as the heart of any business. In garments manufacturing, marketing and merchandising department do two types of activities, one is operational and other is marketing. Merchandising department plays vital role from the start of an order to end of the order. They follow up the process of all shipment as a result this team need to communicate with all other department. In EKCL merchandising department named as "M&M" means Merchandising & Marketing. The working procedures of M&M are given below:

- Collect the data and technical information from the buyer
- > Develop a sample as per requirement from PD.
- Confirmation of order
- Analyze contract sheet and TP
- Collect master L/C copy from buyer end

- Analyze of PO and execution of order
- Collect the ordered goods
- ➢ Make style wise PI
- ➢ Based on master L/C, open B2B L/C
- According to the TP get the consumption & SMV for costing
- Analyze source of order materials
- Negotiate price with the vendor
- Provide testing procedure as per requirement
- Make technical sheet and trim card and provide to operation team
- Meeting with others team like IE, PD, QA, Planning, Production and other's relevant team.
- > Making sample as per buyer requirement and get the approval for bulk production.
- Contact with the buyer if create any issue
- ➢ Follow up bulk production
- Inspection booking and sending the product as per shipment date
- > Other shipment related issue that helps to insure shipment in intime

I have spent some time in my internship period in merchandising and marketing department and learnt about their core activities. From my experience this department plays a vital role in garments manufacturing.

Product Development

This department is the key section of garments manufacturing industries. PD department works in two different segment. One is Technical Team and other one is Sample section. Technical team do their all technical activities that are given below;

- Analyzing TP and make the requirement
- Ensure threat and fabric consumption
- Make technical instruction sheet
- Give technical support which needed
- Arrange risk analysis meeting for every style

Other section named sample section make sample for getting order and get order approval from the buyer. The key task's of sample section are given bellow:

- Make all sample as provided instruction
- Ensure filling of the sample and measurement
- ➤ Make easier sample that help for bulk production
- Make pattern in CAD system
- Execute meeting for pre-sample development

In the period of my internship I have spent some time that help me to know about the product development department. They used different technical solution for different process. Machine verity for different sample and use CAD system. The strong point of the PD section is that all the sample man are highly skilled and good management system. This department have a Design studio and use automation.

<u>Cutting section</u>: In cutting section provide the cut panel from the fabric as needed. Cutting section give the physical shape as pattern design. To get quality full product cutting is highly important. I have learnt about the cutting procedure that are given below:

- Receive fabric from the store and keep in order
- Make plan for cutting as per order quantity
- Fabric relaxation
- Spread fabric in cutting table
- Cut fabric following marker that provided by technical section
- Numbering of all parts
- Quality cheek
- Replace cut panel
- Bundling the panel

I observe closely in cutting section and have learnt about the cutting procedure and other activities of cutting section. In EKCL cutting section use two types of machine that are automatic & spreading cutting machine and straight knife and manual spreading machine. Manual spreading is machine is used stripe fabric and for solid fabric automatic & spreading machine is used.

Sewing Section: Garments are prepared in the sewing section so this section is called main operational section. To make the garment this section used the cut panel which are provided by the cutting section and produce good quality products. I have spent most of the time in the sewing section and learnt about these operation how to accomplished:

Follow up plan for upcoming layout

- Making machine layout as per plan
- > Allocated right operator that means right man at right place
- Feeding input to sewing line for production
- > Sewing all the cut panel following the given instruction
- Check all the sewing garment in all process
- Send quality full garments to the finishing section.

I have done my work closely in the sewing section. This section use skilled operator to produce the good garments. In EKCL have good reputation for producing quality full product. From sewing section I have learnt about different machine layout and optimization manpower. And also learnt about different kinds of sewing machine and uses of these machines.

From sewing section I have familiar with these kinds of machine:

- ✓ Single needle lock stich machine
- \checkmark Feed of the arm machine
- ✓ Flat lock
- ✓ Over lock machine
- ✓ Kansai special machine
- \checkmark Button hole machine
- \checkmark Button attach machine
- ✓ Bar tack machine

- ✓ Fusing attach machine
- ✓ Flat seam machine
